



Boarding Contract Terms & Conditions

1. The Animal Keeper is not responsible for any loss or damage of any owner beds, blankets, toys, carriers, etc. Initials: _____
2. I understand that if I do not check out my pets at 12 noon, I will be charged an afternoon pick up fee. \$25 per dog, \$18 per cat after 12:00pm, \$35 per dog, \$29 per cat after 03:00pm, and full boarding night after 5:00pm. Initials: _____
3. You are obligated to provide complete, truthful, and accurate information regarding any medical conditions, aggressiveness, or other conditions of your pet and agree to inform us of any changes or new information. Initials: _____
4. The Animal Keeper is not responsible for any pre-existing or breed-related conditions, as well as any conditions that are stress induced. All boarding Pets must be healthy at the time of drop off. Initials: _____
5. The Animal Keeper is **NOT** liable for any expense related to illness suffered by your Pet during or after its stay, including, but not limited to any illness or infection, i.e. giardia, tracheobronchitis (kennel cough), feline upper respiratory infections, canine influenza, parvo, distemper, leptospirosis. 6. **Emergency contact.** In the event you are unable to be reached in case of emergency. You must provide a contact, over the age of 18, and be someone other than the primary Pet Parent(s). If we cannot reach you, you authorize The Animal Keeper to contact your emergency contact. You authorize your emergency contact to pick up your Pet and make any and all decisions for your Pet, including health-related decisions, and the expenditure of funds for (or on behalf of) your Pet. 7. **Emergencies.** In the event of an emergency or natural disaster, we will attempt to contact you or your emergency contact to retrieve your Pet. You agree that The Animal Keeper, at its sole discretion, is authorized to transport, and/or to make temporary alternative arrangements to house and care for your Pet until you or your emergency contact can retrieve the Pet. You understand it may not always be possible to safely evacuate your Pet despite our best efforts. Initials: _____
8. **Recreational programs.** All dogs in a play group must be spayed or neutered by 7 months, as well as tested in a group play trial beforehand. If a dog is assessed not apt for group play, then a private play will be provided. Qualifications will be at The Animal Keeper's discretion based on behavior. As the owner I fully understand that The Animal Keeper cannot be held responsible for the consequences of normal behavior of dogs in a group environment such as: scratches, tears, sprains and injuries of the sort.
